Advanced Air Mobility

Last month we highlighted the significant amount of VC money going into the category of Defense Technology and observed that given the stable but limited defense budget, much of the value creation might be expected to manifest itself from technology spillover into commercial use cases. One such sector with the potential to transform commercial aerospace (much like investments into "new space" companies are transforming the satellite & space industry – see Quilty Space for more commentary on this), is Advanced Air Mobility (AAM).

Publicly disclosed investment in this sector grew from \$180 million in 2019 to \$5.8 billion in 2021. The large prime contractors are even devoting significant investment, as demonstrated by Boeing's \$450 million investment in Wisk Aero last year.

While the financial returns are uncertain, investors and regulators are devoting significant resources into this sector, making it one to keep our eye on.






10-Yr Historical EBITDA Multiples*






