

# **May 2023 Market Snapshot**

### **OBSERVATIONS & TAKEAWAYS:**

### Valuations:

- 1. 2023 industry valuations are trending 1.5x 2.0x turns of EBITDA higher than in 2022 (pg 3)
- 2. Industry valuations have trended steadily higher over the past decade, currently standing at 15.2x EBITDA as compared to 8.6x 10 years ago (pg 3)

#### Deal Flow:

- 1. US M&A deal flow has dropped off dramatically (pg 5)
  - Only 731 transactions in May; roughly half of 2022 monthly trends
- 2. Industry deal flow has expanded significantly in 2023
  - 2023 YTD average of 18.4 deals per month
  - Last 7 months of 2022 averaged only 12 deals per month

### Other Commentary - Things to Watch:

- 1. Budget Process Can we restore regular order and move away from continuing resolutions?
- Emergence of the Defense Unicorns Is there enough TAM to justify \$1B+ valuations?
- 3. Opportunities in the lower middle market Are there enough pools of investment capital to continue to drive deal flow?








