
### **Developments defining the future of aviation**

Our thanks to Dan Wolfe, President of AUVSI Hampton Roads, for the invitation to the Advanced Air Mobility (AAM) Exposition that took place at the end of September. Industry leaders, state officials, and federal representatives gathered to discuss the rapidly evolving world of AAM and showcase some exciting developments that are reshaping the future of aviation. These developments are made possible by groundbreaking advancements in electric propulsion, lithium batteries, hydrogen fuel cells, autonomous systems, and supporting infrastructure.

Companies like Joby, Beta Technologies, AIR EV, Regent, Spright, DroneUp, Electra Aero, and others are making remarkable strides in various aspects of AAM. From electric vertical takeoff and landing (eVTOL) aircraft, electric coastal gliders, and hybrid-electric short takeoff and landing solutions to private air transport and remotely piloted autonomous cargo operations, companies like these are revolutionizing the industry. The dual-use capabilities of the technologies being developed (from autonomous drone delivery to re-imagined forms of transportation) underscore that companies like these and the advancements they are making will transform the commercial market while also serving critical roles for the federal government. Some early adopters are already in operation and accepting preorders, and it is anticipated that we may start seeing certified AAM services as early as 2024.

The realization of AAM's full potential, to be sure, hinges largely on infrastructure development and the cooperation of local, state, and federal authorities. Notably, the FAA has approved the nation's first public-use Vertiport in Blackstone, VA, marking a significant milestone. Furthermore, AAM's journey toward safe, scalable commercial operations heavily relies on developments in communication, navigation, and surveillance (CNS) systems, and other autonomous technology to enhance unmanned traffic management and beyond visual line of sight (BVLOS) operations, critical components to the ongoing viability of AAM.

What does all this mean? It is too soon to know who the winners will be but what we do know is that funding, technology and regulatory hurdles are converging toward resolution in the 2024 – 2026 timeframe. Orders on hand will explode as these hurdles are cleared. The business model for certain aviation companies will completely change, others will see greatly expanded markets while many new entrants will converge on the industry. Companies serving the traditional aviation market should be prepared as this will disrupt the aerospace & transportation ecosystem as we currently know it.






### **10-Yr Historical EBITDA Multiples\***


